There does not appear to be a written process to be followed on how the Parish Council gets the community benefit that this application will attract due to the massive impact that this will have on the landscape. There are four potential applications in the surrounding Ludlow area. JRS, AH, CC and RO to consider a meeting to discuss the Community Benefit process.  Rocks Green  Although this application is not within Bitterley Parish, it will affect residents of the parish as there are two properties close to the site. Ludford PC have made comments on the screening application, 22/00581/SCR. The Community Benefit will need to be discussed with the developer. Bitterley Parish Council will not get a notification of the application as its not in the Parish, due to the impact of residents in the parish the clerk to ask Ludford PC when the application is made and if they would consider working with Bitterley PC when the application is submitted.
